**Content of the report:**

The Management Board of ACTION S.A. in restructuring (the Company, the Issuer) hereby informs, that the Company is about to finalise the accounting of documents for July 2017 and therefore would like to communicate about the preliminary estimates of revenue of the ACTION S.A. Capital Group for that period, in amount of 119 million PLN.

At the same time the Management Board emphasizes that the margin achieved by the Company is still on high level i.e. 5,4 %
