Subject: Information about the estimated financial turnover of the Action S.A. Group

Content of the report:

The Management Board of ACTION S.A. in restructuring (the Company, the Issuer) hereby informs, that the Company is about to finalise the accounting of documents for October 2017 and therefore would like to communicate about the preliminary estimates of revenue of the ACTION S.A. Capital Group for that period, in amount of 164 million PLN.

At the same time the Management Board emphasizes that the margin achieved by the ACTION Capital Group is still on high level in estimation about 7,4 %.
