**Content of the report:**

The Management Board of ACTION S.A. in restructuring (the Company, the Issuer) hereby informs, that the Company is about to finalise the accounting of documents for June 2019 and therefore would like to communicate about the preliminary estimates of revenue of the ACTION S.A. Capital Group for that period, in amount of 120 million PLN.

At the same time the Managemnet Board emphasizes that the margin achived by the ACTION Capital Group is still on high level in estimation about 6,5 %.
