Re: Information about the estimated turnover recorded by Action S.A. Capital Group

Content of the Report:

The Management Board of ACTION S.A. (hereinafter: "the Company", or "the Issuer") hereby informs that it is nearing completion of accounting and recording relevant documents for December 2021. Accordingly, the Issuer hereby presents the preliminary information about the estimated turnover recorded by Action S.A. Capital Group for the period considered, which amounts to 236 million PLN.

The Management Board informs that the indicated turnover constitutes an increase of 6% compared to the turnover recorded by the Company in the same period last year, *i.e.* in December 2020.

Additionally, the Management Board emphasises that within the period considered, the gross margin achieved by the entire Capital Group is maintained at a constant high level, estimated at approximately 7.7%.
