Subject: Acquisition of the Company's shares under the share buyback programme.

Legal basis: Other regulations

Text of the report:

The Management Board of ACTION S.A. (hereinafter also: the "*Issuer*", the "*Company*") with reference to current report No. 51/2024 of June 19, 2024,) announces that as part of the execution of the programme of acquisition of own shares under the authorisation granted in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of June 19, 2024 (taking into account the changes based on the Resolutions no. 3 and 4 Extraordinary General Meeting of ACTION S.A. of January 9, 2025), as well as in accordance with the detailed conditions for acquiring own shares published in the current report No. 52/2024 of June 19, 2024 and in current report no. 7/2025 of January 09, 2025, the Issuer made the following acquisitions of the Company's shares (ISIN code: PLACTIN00018) in the period from January 30, 2025 to February 05, 2025 during trading sessions on the main market of the Warsaw Stock Exchange:

- on 30.01.2025, 2,499 own shares with a total value of PLN 51,554.35, for an average unit price of PLN 20.63. These shares constitute 0.0151% of the Issuer's share capital and entitle to 2,499 votes at the General Meeting of the Company, which constitutes 0.0151% of the total number of votes.
- on 31.01.2025, 2,397 own shares with a total value of PLN 49,737.75, for an average unit price of PLN 20.75. These shares constitute 0.0145% of the Issuer's share capital and entitle to 2,397 votes at the General Meeting of the Company, which constitutes 0.0145% of the total number of votes.
- on 03.02.2025, 2,434 own shares with a total value of PLN 50,444.15, for an average unit price of PLN 20.72. These shares constitute 0.0147% of the Issuer's share capital and entitle to 2,434 votes at the General Meeting of the Company, which constitutes 0.0147% of the total number of votes.
- on 04.02.2025, 2,404 own shares with a total value of PLN 50,073.40, for an average unit price of PLN 20.83. These shares constitute 0.0145% of the Issuer's share capital and entitle to 2,404 votes at the General Meeting of the Company, which constitutes 0.0145% of the total number of votes.
- on 05.02.2025, 2,083 own shares with a total value of PLN 44,159.60, for an average unit price of PLN 21.20. These shares constitute 0.0126% of the Issuer's share capital and entitle to 2,083 votes at the General Meeting of the Company, which constitutes 0.0126% of the total number of votes.

As a result of all the aforementioned transactions and the previously acquired shares under the authorizations expressed in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. on June 19, 2024, the Issuer holds a total of 1,301,638 own shares, constituting 7.8711% of the Issuer's share capital and entitling to 1,301,638 votes at the General Meeting of the Company, which constitutes 7.8711% of the total number of votes.

The above transactions of purchase of own shares were carried out through Ipopema Securities S.A. based in Warsaw.
