**Subject:** Acquisition of the Company's shares under the share buyback programme.

**Legal basis:** Other regulations

**Text of the report:**

The Management Board of ACTION S.A. (hereinafter also: the "*Issuer*", the "*Company*") with reference to current report No. 51/2024 of June 19, 2024,) announces that as part of the execution of the programme of acquisition of own shares under the authorisation granted in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of June 19, 2024 (taking into account the changes based on the Resolutions no. 3 and 4 Extraordinary General Meeting of ACTION S.A. of January 9, 2025), as well as in accordance with the detailed conditions for acquiring own shares published in the current report No. 52/2024 of June 19, 2024 and in current report no. 7/2025 of January 09, 2025, the Issuer made the following acquisitions of the Company's shares (ISIN code: PLACTIN00018) in the period from February 20, 2025 to February 26, 2025 during trading sessions on the main market of the Warsaw Stock Exchange:

- on 20.02.2025, 1,711 own shares with a total value of PLN 36,212.65, for an average unit price of PLN 21.16. These shares constitute 0.0103% of the Issuer's share capital and entitle to 1,711 votes at the General Meeting of the Company, which constitutes 0.0103% of the total number of votes.
- on 21.02.2025, 1,729 own shares with a total value of PLN 36,481.90, for an average unit price of PLN 21.10. These shares constitute 0.0105% of the Issuer's share capital and entitle to 1,729 votes at the General Meeting of the Company, which constitutes 0.0105% of the total number of votes.
- on 24.02.2025, 1,773 own shares with a total value of PLN 37,522.40, for an average unit price of PLN 21.16. These shares constitute 0.0107% of the Issuer's share capital and entitle to 1,773 votes at the General Meeting of the Company, which constitutes 0.0107% of the total number of votes.
- on 25.02.2025, 1,759 own shares with a total value of PLN 37,101.95, for an average unit price of PLN 21.09. These shares constitute 0.0106% of the Issuer's share capital and entitle to 1,759 votes at the General Meeting of the Company, which constitutes 0.0106% of the total number of votes.
- on 26.02.2025, 1,757 own shares with a total value of PLN 37,022.70, for an average unit price of PLN 21.07. These shares constitute 0.0106% of the Issuer's share capital and entitle to 1,757 votes at the General Meeting of the Company, which constitutes 0.0106% of the total number of votes.

As a result of all the above transactions and the previously acquired shares under the authorizations expressed in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of 19.06.2024, taking into account their changes made on the basis of the 3rd and 4th Extraordinary General Meeting of ACTION S.A. of 09.01.2025, the Issuer holds a total of 1,330,767 own shares, constituting 8.0472% of the Issuer's share capital, entitling to 1,330,767 votes at the General Meeting of the Company, which constitutes 8.0472% of the total number of votes.

The above transactions of purchase of own shares were carried out through Ipopema Securities S.A. based in Warsaw.
