Subject: Acquisition of the Company's shares under the share buyback programme.

Legal basis: Other regulations

Text of the report:

The Management Board of ACTION S.A. (hereinafter also: the "Issuer", the "Company") with reference to current report No. 51/2024 of June 19, 2024,) announces that as part of the execution of the programme of acquisition of own shares under the authorisation granted in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of June 19, 2024 (taking into account the changes based on the Resolutions no. 3 and 4 Extraordinary General Meeting of ACTION S.A. of January 9, 2025), as well as in accordance with the detailed conditions for acquiring own shares published in the current report No. 52/2024 of June 19, 2024 and in current report no. 7/2025 of January 09, 2025, the Issuer made the following acquisitions of the Company's shares (ISIN code: PLACTIN00018) in the period from May 01, 2025 to May 07, 2025 during trading sessions on the main market of the Warsaw Stock Exchange:

- on 02.05.2025, 2,946 own shares with a total value of PLN 61,772.60, for an average unit price of PLN 20.97. These shares constitute 0.0178% of the Issuer's share capital and entitle to 2,946 votes at the General Meeting of the Company, which constitutes 0.0178% of the total number of votes.
- on 05.05.2025, 3,122 own shares with a total value of PLN 65,562.00, for an average unit price of PLN 21.00. These shares constitute 0.0189% of the Issuer's share capital and entitle to 3,122 votes at the General Meeting of the Company, which constitutes 0.0189% of the total number of votes.
- on 06.05.2025, 3,310 own shares with a total value of PLN 69,744.50, for an average unit price of PLN 21.07. These shares constitute 0.0200% of the Issuer's share capital and entitle to 3,310 votes at the General Meeting of the Company, which constitutes 0.0200% of the total number of votes.
- on 07.05.2025, 3,710 own shares with a total value of PLN 78,381.00, for an average unit price of PLN 21.13. These shares constitute 0.0224% of the Issuer's share capital and entitle to 3,710 votes at the General Meeting of the Company, which constitutes 0.0224% of the total number of votes.

As a result of all the above transactions and the previously acquired shares under the authorizations expressed in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of 19.06.2024, taking into account their changes made on the basis of the 3rd and 4th Extraordinary General Meeting of ACTION S.A. of 09.01.2025, the Issuer holds a total of 2,429,088 own shares, constituting 14.6888% of the Issuer's share capital, entitling to 2,429,088 votes at the General Meeting of the Company, which constitutes 14.6888% of the total number of votes.

The above transactions of purchase of own shares were carried out through Ipopema Securities S.A. based in Warsaw.
