Subject: Acquisition of the Company's shares under the share buyback programme.

Legal basis: Other regulations

Text of the report:

The Management Board of ACTION S.A. (hereinafter also: the "*Issuer*", the "*Company*") with reference to current report No. 51/2024 of June 19, 2024,) announces that as part of the execution of the programme of acquisition of own shares under the authorisation granted in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of June 19, 2024 (taking into account the changes based on the Resolutions no. 3 and 4 Extraordinary General Meeting of ACTION S.A. of January 9, 2025), as well as in accordance with the detailed conditions for acquiring own shares published in the current report No. 52/2024 of June 19, 2024 and in current report no. 7/2025 of January 09, 2025, the Issuer made the following acquisitions of the Company's shares (ISIN code: PLACTIN00018) in the period from July 03, 2025 to July 09, 2025 during trading sessions on the main market of the Warsaw Stock Exchange:

- On July 3, 2025, 2,431 own shares with a total value of PLN 56,027.65, at an average unit price of PLN 23.05. These shares represent 0.0147% of the Issuer's share capital and entitle the holder to 2,431 votes at the Company's General Meeting, which constitutes 0.0147% of the total number of votes.
- On July 4, 2025, 2,000 own shares with a total value of PLN 46,967.10, at an average unit price of PLN 23.48. These shares represent 0.0121% of the Issuer's share capital and entitle the holder to 2,000 votes at the Company's General Meeting, which constitutes 0.0121% of the total number of votes.
- On July 7, 2025, 2,458 own shares with a total value of PLN 58,057.20, at an average unit price of PLN 23.62. These shares represent 0.0149% of the Issuer's share capital and entitle the holder to 2,458 votes at the Company's General Meeting, which constitutes 0.0149% of the total number of votes.
- On July 8, 2025, 2,412 own shares with a total value of PLN 57,888.00, at an average unit price of PLN 24.00. These shares represent 0.0146% of the Issuer's share capital and entitle the holder to 2,412 votes at the Company's General Meeting, which constitutes 0.0146% of the total number of votes.
- on July 9, 2025, 2,480 own shares with a total value of PLN 60,752.70, at an average unit price of PLN 24.50. These shares represent 0.0150% of the Issuer's share capital and entitle the holder to 2,480 votes at the Company's General Meeting, which constitutes 0.0150% of the total number of votes.

As a result of all the above transactions and the previously acquired shares under the authorizations set forth in Resolutions No. 14 and 15 of the Annual General Meeting of ACTION S.A. of June 19, 2024, as amended pursuant to Resolutions 3 and 4 of the Extraordinary General Meeting of ACTION S.A. dated 9 January 2025 and Resolutions No. 16 and 17 of the Annual General Meeting of ACTION S.A. dated 17 June 2025, the Issuer holds a total of 2,521,477 own shares, constituting 15.2475% of the Issuer's share capital, entitling to 2,521,477 votes at the General Meeting of the Company, which constitutes 15.2475% of the total number of votes.

The above transactions of purchase of own shares were carried out through Ipopema Securities S.A. based in Warsaw.
