**Subject:** Acquisition of the Company's shares under the share buyback programme.

**Legal basis:** Other regulations

**Text of the report:**

The Management Board of ACTION S.A. (hereinafter also: the "Issuer", the "Company") with reference to current report No. 51/2024 of June 19, 2024,) announces that as part of the execution of the programme of acquisition of own shares under the authorisation granted in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of June 19, 2024 (taking into account the changes based on the Resolutions no. 3 and 4 Extraordinary General Meeting of ACTION S.A. of January 9, 2025), as well as in accordance with the detailed conditions for acquiring own shares published in the current report No. 52/2024 of June 19, 2024 and in current report no. 7/2025 of January 09, 2025, the Issuer made the following acquisitions of the Company's shares (ISIN code: PLACTIN00018) in the period from July 17, 2025 to July 23, 2025 during trading sessions on the main market of the Warsaw Stock Exchange:

- on July 17, 2025, 2,696 own shares with a total value of PLN 68,478.40, at an average unit price of PLN 25.40. These shares represent 0.0163% of the Issuer's share capital and entitle the holder to 2,696 votes at the Company's General Meeting, which constitutes 0.0163% of the total number of votes.
- on July 18, 2025, 2,794 own shares with a total value of PLN 72,279.80, at an average unit price of PLN 25.87. These shares represent 0.0169% of the Issuer's share capital and entitle the holder to 2,794 votes at the Company's General Meeting, which constitutes 0.0169% of the total number of votes.
- on July 21, 2025, 1,000 own shares with a total value of PLN 26,000.00, at an average unit price of PLN 26.00. These shares represent 0.0060% of the Issuer's share capital and entitle the holder to 1,000 votes at the Company's General Meeting, which constitutes 0.0060% of the total number of votes.

As a result of all the above transactions and the previously acquired shares under the authorizations set forth in Resolutions No. 14 and 15 of the Annual General Meeting of ACTION S.A. of June 19, 2024, as amended pursuant to Resolutions 3 and 4 of the Extraordinary General Meeting of ACTION S.A. dated 9 January 2025 and Resolutions No. 16 and 17 of the Annual General Meeting of ACTION S.A. dated 17 June 2025, the Issuer holds a total of 2,538,100 own shares, constituting 15.3480% of the Issuer's share capital, entitling to 2,538,100 votes at the General Meeting of the Company, which constitutes 15.3480% of the total number of votes.

The above transactions of purchase of own shares were carried out through Ipopema Securities S.A. based in Warsaw.
