Subject: Acquisition of the Company's shares under the share buyback programme.

Legal basis: Other regulations

Text of the report:

The Management Board of ACTION S.A. (hereinafter also: the "Issuer", the "Company") with reference to current report No. 51/2024 of June 19, 2024,) announces that as part of the execution of the programme of acquisition of own shares under the authorisation granted in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of June 19, 2024 (taking into account the changes based on the Resolutions no. 3 and 4 Extraordinary General Meeting of ACTION S.A. of January 9, 2025), as well as in accordance with the detailed conditions for acquiring own shares published in the current report No. 52/2024 of June 19, 2024 and in current report no. 7/2025 of January 09, 2025, the Issuer made the following acquisitions of the Company's shares (ISIN code: PLACTIN00018) in the period from August 07, 2025 to August 13, 2025 during trading sessions on the main market of the Warsaw Stock Exchange:

- on August 7, 2025, 2,044 treasury shares with a total value of PLN 52,881.25, for an average unit share price of PLN 25.87. These shares constitute 0.0124% of the Issuer's share capital and entitle to 2,044 votes at the General Meeting of the Company, which constitutes 0.0124% of the total number of votes.
- on August 11, 2025, 2,299 treasury shares with a total value of PLN 60,503.70, for an average unit share price of PLN 26.32. These shares constitute 0.0139% of the Issuer's share capital and entitle to 2,299 votes at the General Meeting of the Company, which constitutes 0.0139% of the total number of votes.
- on August 12, 2025, 2,168 treasury shares with a total value of PLN 57,452.00, for an average unit price of PLN 26.50. These shares constitute 0.0131% of the Issuer's share capital and entitle to 2,168 votes at the General Meeting of the Company, which constitutes 0.0131% of the total number of votes.
- on August 13, 2025, 2,067 treasury shares with a total value of PLN 54,647.30, for an average unit price of PLN 26.43. These shares constitute 0.0125% of the Issuer's share capital and entitle to 2,067 votes at the General Meeting of the Company, which constitutes 0.0125% of the total number of votes.

As a result of all the above transactions and the shares previously acquired under the authorizations expressed in Resolutions No. 14 and 15 of the Annual General Meeting of ACTION S.A. of 19 June 2024, taking into account their amendments made on the basis of Resolutions 3 and 4 of the Extraordinary General Meeting of ACTION S.A. of 09 January 2025 and Resolutions No. 16 and 17 of the Annual General Meeting of ACTION S.A. of 17 June 2025, the Issuer holds a total of 2,563,590 treasury shares, constituting 15.5021% of the Issuer's share capital, entitling to 2,563,590 votes at the General Meeting of the Company, which constitutes 15.5021% of the total number of votes.

The above transactions of purchase of own shares were carried out through Ipopema Securities S.A. based in Warsaw.
