**Subject:** Acquisition of the Company's shares under the share buyback programme.

Legal basis: Other regulations

## Text of the report:

The Management Board of ACTION S.A. (hereinafter also: the "*Issuer*", the "*Company*") with reference to current report No. 51/2024 of June 19, 2024,) announces that as part of the execution of the programme of acquisition of own shares under the authorisation granted in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of June 19, 2024 (taking into account the changes based on the Resolutions no. 3 and 4 Extraordinary General Meeting of ACTION S.A. of January 9, 2025), as well as in accordance with the detailed conditions for acquiring own shares published in the current report No. 52/2024 of June 19, 2024 and in current report no. 7/2025 of January 09, 2025, the Issuer made the following acquisitions of the Company's shares (ISIN code: PLACTIN00018) in the period from January 09, 2025 to January 15, 2025 during trading sessions on the main market of the Warsaw Stock Exchange:

- on 9 January 2025, 3,491 own shares with a total value of PLN 73,185.00, for an average unit share price of PLN 20.96. These shares constitute 0.0211% of the Issuer's share capital and entitle to 3,491 votes at the General Meeting of the Company, which constitutes 0.0211% of the total number of votes.
- on 10 January 2025, 3,415 own shares with a total value of PLN 71,543.25, for an average unit share price of PLN 20.95. These shares constitute 0.0207% of the Issuer's share capital and entitle to 3,415 votes at the General Meeting of the Company, which constitutes 0.0207% of the total number of votes.
- on 13/01/2025, 3,021 own shares with a total value of PLN 62,809.70, for an average unit share price of PLN 20.79. These shares constitute 0.0183% of the Issuer's share capital and entitle to 3,021 votes at the General Meeting of the Company, which constitutes 0.0183% of the total number of votes.
- on 14/01/2025, 2,842 own shares with a total value of PLN 57,821.05, for an average unit share price of PLN 20.35. These shares constitute 0.0172% of the Issuer's share capital and entitle to 2,842 votes at the General Meeting of the Company, which constitutes 0.0172% of the total number of votes.
- on 15/01/2025, 2,846 own shares with a total value of PLN 58,117.20, for an average unit price of PLN 20.42. These shares constitute 0.0172% of the Issuer's share capital and entitle to 2,846 votes at the General Meeting of the Company, which constitutes 0.0172% of the total number of votes.

As a result of all the aforementioned transactions and the previously acquired shares under the authorizations expressed in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. on June 19, 2024, the Issuer holds a total of 1,263,006 own shares, constituting 7.6375% of the Issuer's share capital, entitling to 1,263,006 votes at the General Meeting of the Company, which constitutes 7.6375% of the total number of votes.

The above transactions of purchase of own shares were carried out through Ipopema Securities S.A. based in Warsaw.
