**Subject:** Information on ACTION Capital Group's turnover estimate

**Legal basis:** Article 17(1) of MAR – confidential information

**Text of the report:**

The Management Board of ACTION S.A. (the Company, the Issuer) hereby informs that the booking process of accounting documents for the month of April 2026 is nearing completion and therefore it announces the preliminary turnover estimate of ACTION Capital Group for this period that amount to PLN 236 million. At the same time, the Issuer points out that the turnover generated in this period increased by approx. 2,61 per cent on the turnover recorded by the Company in the same period of the previous year, i.e. in April 2025. The Management Board stresses that in the reporting period the margin generated by the Group continues to remain on a high level of an estimated approx. 8,47 per cent.
