Subject: Acquisition of the Company's shares under the share buyback programme.

Legal basis: Other regulations

Text of the report:

The Management Board of ACTION S.A. (hereinafter also: the "*Issuer*", the "*Company*") with reference to current report No. 51/2024 of June 19, 2024,) announces that as part of the execution of the programme of acquisition of own shares under the authorisation granted in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. of June 19, 2024, as well as in accordance with the detailed conditions for acquiring own shares published in the current report No. 52/2024 of June 19, 2024, the Issuer made the following acquisitions of the Company's shares (ISIN code: PLACTIN00018) in the period from September 12, 2024 to September 18, 2024 during trading sessions on the main market of the Warsaw Stock Exchange:

- on 12 September 2024, 1,773 own shares with a total value of PLN 33,346.66, at an average unit share price of PLN 18,81. These shares constitute 0.0107% of the Issuer's share capital and give the right to 1,773 votes at the Company's General Meeting, which constitutes 0.0107% of the total number of votes.
- on 13 September 2024, 1,640 own shares with a total value of PLN 30,830.24, at an average unit share price of PLN 18,80. These shares constitute 0.0099% of the Issuer's share capital and give the right to 1,640 votes at the Company's General Meeting, which constitutes 0.0099% of the total number of votes.
- on 16 September 2024, 1,619 own shares with a total value of PLN 30,309.12, at an average unit share price of PLN 18,72. These shares constitute 0.0098% of the Issuer's share capital and give the right to 1,619 votes at the Company's General Meeting, which constitutes 0.0098% of the total number of votes.
- on 17 September 2024, 1,623 own shares with a total value of PLN 30,458.98, at an average unit share price of PLN 18,77. These shares constitute 0.0098% of the Issuer's share capital and give the right to 1,623 votes at the Company's General Meeting, which constitutes 0.0098 of the total number of votes.
- on 18 September 2024, 1,627 own shares with a total value of PLN 30,489.98, at an average unit share price of PLN 18,74. These shares constitute 0.0098% of the Issuer's share capital and give the right to 1,627 votes at the Company's General Meeting, which constitutes 0.0098% of the total number of votes.

As a result of all the aforementioned transactions and the previously acquired shares under the authorizations expressed in Resolutions No. 14 and 15 of the Ordinary General Meeting of ACTION S.A. on June 19, 2024, the Issuer holds a total of 1,086,657 own shares, representing 6.5711% of the Issuer's share capital, giving it the right to 1,086,657 votes at the Company's General Meeting, representing 6.5711% of the total number of votes.

The above transactions of purchase of own shares were carried out through Ipopema Securities S.A. based in Warsaw.
